

Be able to work well with others (and others who are on the Board)

Be known for great ideas and solid input on projects (can provide references)

Not be related to another board member

Not working for a competing organization, or one that engages in activities detrimental to the human/canine bond and responsible pet parenting

Be physically and financially able to serve as a Board Member (able to travel if needed)

Willing to attend all board meetings (either in person, by phone or by proxy)

Have a computer, telephone, email account, and is able to communicate via email

Be a person who will promptly respond to emails, phone calls, board memos, and give all issues before the board and concerning DSA thought and express their honest opinion or cast their vote.

Will put the best interests of the organization first when considering items before the board

Be of sound mind and body (sane and healthy)

Have a strong work ethic they can apply to the position. Responses and delegated tasks will be addressed in a timely manner.

Agrees to step down if no longer able to perform the duties required

Have experience in one or more of the following fields:

- running a successful business
- fundraising
- planning
- human resources
- accounting
- marketing
- research
- has served on a Board of Directors

## Dog Scouts of America has just had our first Audit!



In an effort to get DSA in a better position to receive grant monies, we had an audit of our books. This is not necessarily a time when we could AFFORD this audit, but it is a time of transition, when we could not exactly afford NOT to! Our organization is entering into a time of hope for growth, both physically and financially, and we felt

the audit will help us get the much needed donations and grant monies that are available.

During this time, we especially appreciate all members donations of funds, time, and materials. Your donations are tax deductible. Please think of DSA and include us in your giving plans.

There are many ways of contributing to our organization. You could serve on a committee, run for a board position, contribute your ideas, time and effort, but we especially need your financial contribution! There are also many ways to contribute financially to our organization.



Of course, you can always send us a check or go online to offer a donation through Pay Pal at our web site. I was very impressed by a donation I received for two dollars the other day. I'm guessing that if the donor could have afforded more, he would have, but I was impressed by the fact that he took the time to go through the donation process online to give us a few dollars that he COULD spare. We must have done something meaningful for him that changed his life forever for him and his dog. I'm sure we do this for a lot of people, and if you try to put a price tag on this, it's hard to do. I would hope that more people who find that we've helped them in some way to form a better relationship with their dog would opt to send a donation.



Another way to do this is to opt for the Contributing or Sustaining membership option when you renew your dues. By doing this, you get the same membership services you have always enjoyed, but everything over and above the regular membership amount goes as a donatic state of the contribution of the contri

tion to DSA. You also get a new membership number, reflecting the fact that you chose to support DSA with a Contributing or Sustaining membership. This is designated by a C or an S with your current number. You will also receive a nice gift of a gold tone ornament featuring our founder (Border Collie, Karli, the first Dog Scout) to thank you for

your contribution.

Don't forget that you can also help DSA with "Planned Giving," which is to leave money set aside for DSA in a will or a living trust. This way, you can leave a legacy

of helping promote responsible pet parenting, even after you have left the earthly plane. It can be done through a charitable remainder trust, or an endowment fund, or even as simply as having your bank account designated as POD (payable on your death) to DSA. I have this on my own bank account, instead of naming a family member as a joint member on the account, I have named DSA as the benefactor, so the money goes directly to them in the event of my death, in addition to everything that I have left to DSA in my will.

I am hoping that DSA will be around for a very long time, but we are a publicly supported nonprofit organization, and we count on your donations for our continued success.

# 2008 Annual Report

DSA had a busy 2008. We have decided that we need to start delegating work to more committees, encourage more people to run for board positions, try to get more people to volunteer for stuff, and seek the services of a Resource Developmental Director and Fundraising Manager. We want to really get Dog Scouts on the "map" (or at least on everyone's lips) around the world, and to do so, we need funds.

The organization depends on camp enrollments for much of its day-to-day operational

funds, but the economy is not cooperating. Enrollments are down, and the year-end report does not show a good bottom line. Next year's projections don't look much better, if we don't identify a source of funds, soon. I'd like to ask everyone out there to put on your thinking caps, volunteer to work on committees, grant-write, or give us your ideas for fundraisers. If you have experience in any of these areas, please let our Board of Directors know

I know that when times are hard is not the



best time for us to come asking for donations, but if you can find a few spare dollars to send to DSA, it will help our outlook for 2009. Remember, that giving can take many forms. It warmed the cockles of my heart the other day, when we received a \$2.00 donation from a stranger (via Pay Pal).

This individual probably read our web site, and found something profound that helped enrich his life with his dog, and was moved to send us a donation. It doesn't matter the size... I was so

tickled to think that someone would go to the trouble to initiate a Pay Pal transaction for two dollars. If all of our members donated two dollars today, we'd have an extra thousand dollars to get us through the lean times. Remember that many companies (maybe the one you work for) have matching donation policies. This would double any donation that you would send our way.

There is also the donation of goods and equipment, which helps out a lot. You can help by registering with escrip, and having a portion of your charge card expenditures go to DSA. You can also create a trust, or put Dog Scouts of America in your will. Troops can also hold fundraisers to help support the national organization. There are many ways to help, and we appreciate you thinking of DSA with your donations.

The home office is undergoing an audit, so that we will look better to potential grant funders. This audit will cost us close to \$6,000.00, but hopefully, it will help us get more funding. I am awaiting the final packet right now, and when I get the financial part of the annual report, I'll put the information in the newsletter.

Well enough of the appeals for funds...

I am so pleased with the accomplishments of the troops this year. All you have to do is read the Scoop to see what marvelously talented people are doing out there. It warms my heart. Chris Puls has been very busy helping many new troops get started. We have really grown in 2008! She has also been busy viewing tapes from our new Worldwide Scout Certification Program. Lots of people have been able to take advantage of the option to become certified with their dogs as Dog Scouts via You Tube or sending in a video.

Chris has also developed the "Dog Scouts Welcome" program, offering businesses the opportunity to allow dogs who are scouts and have responsible owners at the other end of the leash, to enter their establishments

Judy Harris hosted the first Missouri Mini Camp last May, which was a great success.

We are developing several new badges, which will be available this coming year. Kayaking, Canoeing, Canine CPR, Puissance Jumping, and Trail Companion are all in the works. Trail companion involves horses and dogs, and because of the adoption of several horse rescues this past year by Lonnie and Ed, we will be able to offer this badge at camp in the future.

Several troops submitted the paperwork to become official nonprofit 501 (c) (3) subgroups. This new status will allow them to raise funds and apply for grants just like the

Central Organization. We just got the determination letter from the IRS stating that they have been accepted. Any troops who would like to pursue this course, please contact President, Lonnie Olson.

After several appeals to the board from our wonderful newsletter editor, Grace Stevens, to go to a digital format for the newsletter, we are going to "go green," and step into the 21st century, and do just that. This will make it easier on our newsletter editor, and it will kill fewer trees than the old-fashioned way. Anyone who does not have an email account can get a free one through yahoo, and can get their copy of the news online by visiting the local library, but if you live 50 miles away from the nearest library, and can not do this, we're looking for an alternative that will not be inconvenient for our members or our membership and newsletter departments. Thanks for your cooperation and your patience.

I am very excited for the future of DSA, and I hope you are, too. Chris Puls has officially taken over the reins as President. Please show her the same great support and friendship that you have shown me over the last 14 years.

Here's to a productive and prosperous 2009!

#### Dog Scout "Martini" is Honored as a Therapy Dog

My therapy dog and Dog Scout Troop Member of Troop #119, Martini (I Ma Winter's Tale, CGC, TDI AOV,DSA) was honored by the American Whippet Club at its National Specialty in Atlanta, GA on Saturday night, April 11, receiving this year's esteemed Willow Award for excellence in the field of therapy work. Willow was a Whippet, officially named FC Warburton Song Sung Blue, CD, FCh, TRP, AV, TT, CGC, Delta Therapy Dog. She is the only Whippet in history to be the recipient of an American Kennel Club Award for Canine Excellence (ACE), and by bestowing an award in her name to other Whippets performing outstanding therapy service, the American Whippet club honors, in addition to the recipient, her life and her labors in loving memory and perpetuation. Willow was such a special dog - we are very humbled and honored. This is Martini's second therapy award in just a few months. In December 2008, Martini was inducted into the Tarrant County Veterinary Medical Association's Animal Hall of Fame. Tonight we are scheduled to visit the facility where we made our very first visit. The timing is perfect. We are so proud to be associated with Dog Scouts of America. # From your friendly neighborhood Recognition Program Coordinator:

There has been a large increase in the number of merit badge submissions I am receiving on a monthly basis. This is, I'm sure, due to the increased number of Scoutmasters & Evaluators being approved across the country, as well as more people submitting badges via video. Unfortunately, with the increase of badge form submissions has come an increase in errors with the submissions. Due to the volume of submissions I am receiving each month, I am only able to dedicate one weekend per month to work on the submissions. When something is sent with errors, it delays processing by at least a month, or until I am able to obtain the correct information. Therefore, I am posting this notice as a reminder of things to check your submissions for before putting them in the mail to me for processing.

- 1. Please make sure all documentation is attached to your badge form, including photos and log sheets as needed
- 2. Please be sure you are including the proper portion of the badge form (bottom half signed by an Evaluator).
- 3. Please be sure you are paying the correct amount for the badge(s) requested and that your checks are made payable to DSA, not to me.
- 4. For DSA badges, please submit a digital photo for the photo i.d. badge whenever possible rather than a printed photo. For multiple photos submitted, please be sure to label each photo properly with the dog's name as I don't always guess correctly! Also, realize that I do not have Photo Shoppe so the photo on your dog's i.d. badge is only going to be as good as the photo you submit.

Two dogs from our troop presented the local fire department with the oxygen masks that were purchased by the Leaders from the 2008 Leader Retreat.




Our troop President, Vickie Thompson, participated in an area "Safety Day" where she talked to people about responsible pet parenting with Jesse, her Standard Poodle.

# Help DSA Get an AED!

An AED (defibulator) can save lives. Your chance of surviving a heart attack diminishes by another 10% for each additional minute it takes



the ambulance to arrive and begin life-saving measures. Many businesses are now getting defibulators that can be operated by a trained

person who is not necessarily an EMT or a Doctor. I would say that over half of our campers are over 50 years of age. While we have never had a close call at camp, I would certainly hate to have something happen when we could have prevented it with the purchase of one of these life-saving devices. We discussed this purchase last year, but were unsure of the legal ramifications if the device was used to TRY to resuscitate someone, but they couldn't be revived. Here is what Wikipedia says about that concern: Most health professionals agree that automated external defibrillators are so easy to use that most states in the US now include the "good faith" use of an AED by any person under the Good Samaritan Law, "Good faith" protection under a Good Samaritan law means that a volunteer responder (not acting as a part of one's occupation) cannot be held civilly liable for the harm or death of a victim by providing improper or inadequate care, given that the harm or death was not intentional and the responder was acting within the limits of their training and in good faith. In the United States, Good Samaritan laws provide some protection for the use of AEDs by trained and untrained responders. AEDs create little liability if used correctly; NREMT-B and many state EMT training and many CPR classes incorporate or offer AED education as a part of their program. In addition to

Good Samaritan laws, Ontario, Canada also has the "Chase McEachern

Act (Heart Defibrillator Civil Liability), 2007 (Bill 171 – Subsection N)", passed in June, 2007, which protects individuals from liability for damages that may occur from their use of an AED to save someone's life at the immediate scene of an emergency unless damages are caused by gross negligence.

Some of our staff has already had training for the use of a defibulator. The Board of Directors has voted to have DSA purchase one of these

devices. However, they are very expensive, and Dog Scouts does not have it in the budget to purchase a machine that will cost up to \$2,000.00.

We need to have a fund raiser to pay for the purchase of our AED. Please donate, if you support our decision to be prepared in the event of an emergency. The life you save could be your own! We'd like to purchase this before the coming summer's camps, so please make any donation that you can afford. You could become someone's hero!
